TERMS & CONDITIONS OF SKIP HIRE SERVICES

- By placing an order you agree to abide by our Terms & Conditions.
- The Hirer/Customer/Site Workers are prohibited from assisting the driver whilst they operate the lifting equipment.
- **NO** cement board, batteries, fuel tanks, toxic waste, paint, gas bottles, tyres & tracks, liquids, japanese knot weed, faeces, safes. Such waste will be refused or subject to a surcharge.
- **NO** Asbestos. Prior notification with KJ Millard Ltd and authority from the Environment Agency is required. All asbestos including untested items found will be isolated, the Hirer contacted and asked to collect or pay for appropriate disposal.
- Fridges, freezers, all window / conservatory / greenhouse glass, astro turf and tyres only by prior agreement and will be subject to a surcharge.
- Waste Electronic and Electrical Equipment (WEEE) **must** be kept separate from other waste
- Plasterboard and all gypsum based materials **must** be separated from general waste.
- The Hirer is responsible for **all** materials placed in the skip.
- Skips **must not** be loaded above the top of the skip. Materials must not be used to increase the size of the skip. Drivers may **refuse** to collect an overloaded skip or may unload any surplus. Additional charges for this may apply.
- Strictly **no** fires in or near a skip, any damage caused will be the liability of the Hirer.
- Strictly **no** ash residue. Incinerator bottom ash or any residue arising from burning waste **must** be disposed of via a specialist hazardous waste carrier.
- Waiting time charges may be incurred if the driver is kept on site for longer than 30 minutes.
- If the skip is to be placed on the highway, KJ Millard Ltd will arrange appropriate permits at the Hirer's cost. Road permits are non-refundable once applied for. The Hirer is responsible for ensuring the lights are lit when daylight fades.
- KJ Millard Ltd accept **no** responsibility for any damage caused to any property or services above or below ground following the Hirer's request for us to leave the public highway and enter private property.
- The Hirer is responsible for **any and all** damage incurred to the skip(s) whilst on hire, including theft.
- It is the Hirer's responsibility to protect driveways, manholes, trees and shrubs when our vehicle is asked on to private property.
- Skips should be available for collection within **3 weeks** of delivery for non-account customers or hire charges will apply.
- Maximum hire period for account customers is **3 months**. We hold the right to collect skips without prior notification.
- **Do not** reposition skips after delivery as this can increase the risk of damage when removing the skip.
- Cancelled orders and aborted journeys may incur a charge.
- Refunds on card payments are charged at £10 per transaction.
